## 2024 WARRANT

#### Article 02 General Government

To see if the town will vote to raise and appropriate the sum of Four Hundred Thirty-Two Thousand Five Hundred Thirty-Two Dollars (\$432,532) for general municipal operations. This article does not include appropriations contained in special or individual articles addressed separately. (Majority vote required)

#### Article 03 Highway Department

To see if the town will vote to raise and appropriate the sum of Three Hundred Fifty-Six Thousand and Seventeen Dollars (\$356,017) for maintenance, expenses, salaries, equipment and street lighting for the Highway Department for the ensuing year. (Majority vote required)

#### Article 04 Election, Registration & Vitals


To see if the town will vote to raise and appropriate the sum of Fifty-Two Thousand Seven Hundred Seventy-Three Dollars (\$52,773) for expenses, salaries, supplies, and equipment for the Election, Registration & Vitals Department for the ensuing year. (Majority vote required)

## Article 05 Add Funds to Highway Equipment Capital Reserve Fun

To see if the Town will vote to raise and appropriate the sum of Thirty-Seven Thousand Dollars (\$37,000) to be added to the Highway Equipment Capital Reserve Fund previously established. (Majority vote required) (Recommended by the Selectmen)

### Article 06 Add Funds from Fund Balance to Highway Equipment C

To see if the Town will vote to raise and appropriate the sum of Thirteen Thousand Nine Hundred Six Dollars (\$13,906) to be added to the Highway Equipment Capital Reserve Fund previously established with said funds to come from unassigned fund balance (These funds represent a One Time Highway Block Grant payment received from the State of New Hampshire). (Majority vote required) (Recommended by the Selectmen)

#### to Road Mat

To see if the Town will vote to raise and appropriate the sum of Forty Thousand Dollars (\$40,000) to be added to the Road Material Capital Reserve Fund previously established, with said funds to come from unassigned fund balance (These funds represent an American Rescue Plan Act payment received from the Grafton County American Rescue Plan Fund). (Majority vote required) (Recommended by the Selectmen)

# Article 08 Add Funds to Road Material Capital Reserve Fund

To see if the Town will vote to raise and appropriate the sum of Twenty-Five Thousand Dollars (\$25,000) to be added to the Road Material Capital Reserve Fund previously established. (Majority vote required) (Recommended by the Selectmen)

# Article 09 Add Funds From Unassigned Fund Balance to Highway

To see if the Town will vote to raise and appropriate the sum of Five Thousand One Hundred Seventy-Seven Dollars (\$5,177) to the Highway Bridge Replacement and Repair Capital Reserve Fund previously established, with said funds to come from unassigned fund balance (These funds represent a One Time Bridge Repair Payment received from the State of New Hampshire). (Majority vote required) (Recommended by the Selectmen)

# Article 10 Add Funds to Transfer Station Equipment & Repair C

To see if the Town will vote to raise and appropriate the sum of Two Thousand Dollars (\$2,000) to the Transfer Station Equipment & Repair Capital Reserve Fund previously established. (Majority vote required) (Recommended by the Selectmen)

# Article 11 Create Hazard Mitigation Captial Reserve Fund

To see if the town will vote to establish a Capital Reserve Fund under the provisions of RSA 35:1-c for the purpose to defray the quinquennial (5-year) cost to update the town's Hazard
